- Rajpur, Ta.: Kadi, Mehsana 382 715, has filed its proposal for Academic Year 2024-25 for Pre Primary, Primary (Std. 1 to 8) and Secondary Section (Std. 9 & 10) (CBSE English Medium) along with relevant documents. We have gone through the papers submitted along with proposal. It appears that the school has produced accounts for the year: 2021-22 & 2022-23. The school has also provisional statement of income & expenditure for the period 01-04-2023 to 30-09-2023. It appears that the strength students is 146.
 - (2) It has come to the notice of this committee that after the judgment of Hon. High court of Gujarat in special civil application No. 2356/2021 dated: 22-07-2022, many schools have started to collect additional term fees extra. We have not found any clarification that whether this applicant school has collected two months term fees over and above the fees determined by the committee or not.
 - (3) FRC has considered section 10(3) of "The Gujarat self financed schools (Regulation of fees) Act. 2017", which is reproduced as under.

The fee regulatory committee shall determine the total fees which shall be levied by considering all different fees charged by the school.

- (4) The committee has also gone through the judgment delivered by Hon. High court of Gujarat in SCA No. 2356/2021 dated 22.07.2022.
 - The School has submitted its income and expenditure Statement for the year 2023-24, Looking to the Statement and on verifying the above statement it is found that some of the expenses like Operational Expenses, Electricity Expenses, Advertisement Expenses, Depreciation, Repairs & Maintenance, Consultancy Service Charges etc. are not justifiable because they are either excess or without explanation hence found disallowable and not for education purpose. And by considering the strength of the student's it

is found that the proposed fee structure is not found satisfactory. But looking the teacher's salary some reasonable fee structure determines by the FRC.
